# **CAPITAL IMPROVEMENT ACTIVITIES**

### Asphalt Crack Filling and Patching:

Macadam Company has scheduled the asphalt crack filling of the entire community, and asphalt patching areas in need of repair for the end of October.

#### **Tennis Courts Gates and Locks:**

At the request of Council, Management is in the process of obtaining proposals to repair the gates at both tennis courts and replace the locks.

# ASSOCIATION ACTIVITIES – Operating Fund Projects and Activities

#### Landscaping:



Clarke's Landscaping cut this week, making it 21 cuts so far this season. Due to the excessive rains and height of the grass, Management received a few unavoidable complaints regarding the grass cutting this past period.

The Fall fertilizer and broadleaf herbicide application was scheduled for Thursday, September 29<sup>th</sup>. Due to inclement weather it was postponed to Tuesday, October 11th.



Clarke's Landscaping is in the process of removing the dead or dying trees, removing stumps and pruning those trees in need. The new tree plantings will take place in October.

Treacy Landscaping will start chipping the landscaping debris at the pole barn once the ground is dry in that area.

The in-house staff removed unruly shrubs around a few utility boxes, graded and seeded these areas. The Fall seeding will take place over the next couple of weeks. Mums and pansies were planted at the entrances.



#### **Door Painting:**

Matt Frisco and Jeff Derstein successfully completed painting doors in Jefferson, Cross Hill, Clarella, Hillock, Brunswick, and Lexington Courts. Matt and Jeff are in the process of painting the doors on Mulberry Court, which is the last court scheduled for this year.

#### Shutter Painting:

The in-house staff is preparing for the shutter painting and replacement this winter, with Mulberry Court being first on the schedule.

#### Swimming Pool:

The pool is closed for the season. Most of the outdoor pool furniture has been stored away, and Berardelli Pool Services winterized the pool filtration system.



#### **Storage/Bike Shed Locks:**

During the week of August 22<sup>nd</sup>, the in-house staff cleaned out the storage sheds and disposed of any untagged or prohibited items.

On September 13, 2011, the locks were changed on all of the storage sheds. Carolyn Carr, Community Administrator, created an efficient, well organized process for residents to exchange or purchase a new storage shed key. To date, thirty-six (36) residents exchanged or purchased new keys, which equates to \$570.00 in storage shed income allocated for repairs.

#### Maintenance Activities:

In addition to the work orders, the in-house staff has been working the majority of time this past month with painting doors, cleaning the storage/bike sheds, removing shrubs, and weeding tree beds. The trash cans and dog stations were emptied several times this past period. This month the in-house staff delivered the August newsletter, tree work notices and painting notices to those not registered via e-mail.

# August 18, 2011

A regular meeting of the Board of Directors of Morgandale Condominium Association, Inc. ("Morgandale" or the "Association"), constituting the Council of Morgandale, was held in the Edwardian Clubhouse of Morgandale, Towamencin Township, Montgomery County, Pennsylvania, on Thursday, August 18, 2011. Materials distributed to the members of Council in advance or at the meeting were filed with the meeting records.

The following directors were present, constituting a quorum of the Council: Timothy O. Cooney, President, Gary Cassel, Vice President, and Barbara Crippen, Secretary. Also present was Jill Geiger, Community Manager, Carol Richard, Regional Director, Mid-Atlantic Management Corporation, and Jeffrey Anderson, Recording Secretary. Ed Trbuza, Treasurer and Joan Cossman, 2<sup>nd</sup> Vice President, were absent.

Tim Cooney called the meeting to order at approximately 6:30 pm. Four residents attended.

# APPROVAL OF MINUTES

The minutes of the regular council meeting for July 28, 2011 were reviewed. On a motion from Gary Cassel, seconded by Barb Crippen, Council approved the minutes as presented.

# FINANCIAL REPORT

The unaudited Treasurer's Report for the period ending July 31, 2011 was not available for the meeting, as the meeting was held earlier in the month than normal. The report and the financial statements will be delivered to the Council when the Treasurer returns from vacation, the week of August 22, 2011.

#### MANAGEMENT REPORT

Jill Geiger submitted the Management Report covering the period of July 22, 2011 through August 12, 2011. She presented the report which included the Financial Management Status Report, Capital Improvement Activities, Operating Fund Projects and Activities, Administrative Updates and Maintenance Activities. Highlights were discussed.

#### **COMMITTEE REPORTS**

**1. Site** – In Committee Chairperson John Lyon's absence, Jill Geiger, Community Manager reported that there were two new exterior modification approvals and one denial.

**2.** Communications – Tim Cooney, Chairperson, reported that recent newsletters were prepared and distributed on schedule.

**3. Recycling Committee** – Gary Cassel, Committee Chairperson, reported the next committee meeting will be Monday, August 22, 2011.

**4. Pool Committee** – Barb Crippen, Chairperson, reiterated some of the positive feedback on the pool season.

**5.** Adult Pool Party – Joan Cossman, Chairperson, was absent. The members attending the meeting agreed that the party was definitely a success.

**6.** Community Yard Sale – Barb Crippen, Chairperson, informed the members that the next Yard Sale is scheduled for September 24, 2011.

# **ACTION ITEMS**

#### 1. Shutter and Door Painting Proposals -Mulberry Court

Council found it unnecessary to review price proposals to paint the doors and shutters on Mulberry Court, since it was agreed that the in-house staff will complete this work over the next couple of months.

#### 2. Tree Pruning/Removal/Replacement Proposals

After review and discussion of proposals to prune, remove and replace trees throughout the community, on a motion from Barb Crippen, seconded by Gary Cassel, Council approved the proposal from Clarke's Landscaping & Lawn Care, Inc., to be completed not later than the end of September.

#### **3. Front Entrance Bed Project**

Council asked the Community Manager to solicit a proposal from Treacy Landscaping to redesign the entrance bed at the clubhouse between the clubhouse and the Management Office doors.

#### 4. Part Time Employee

Phil Hartley, part time employee, is available until year end when he will return to school. After review and discussion, on a motion from Barb Crippen, seconded by Gary Cassel, Council approved the employment extension of Phil Hartley from summer through year end as a part-time employee for twentyfour hours per week at his current hourly rate.

#### 5. Attic Window

After review and discussion of attic windows, on a motion from Barb Crippen, seconded by Gary Cassel, Council approved that attic windows must be restored back to the original design, either now or at the time of resale.

There being no further business, the meeting adjourned at 7:15 p.m.

# Storm water Pipe Repair — 1600 Belvedere Court

A sink hole appeared on Belvedere Court due to a damaged storm water drain. This large pipe collects water from Morgandale Drive at Belvedere Court, as well as run off from as far up as Pennland Court and beyond. Clarke's Landscaping was called in to excavate to determine the cause. They were unable to dig deep enough to uncover the problem, but by physically crawling up the storm drain, they determined that the pipe had cracked and rusted. Clarke's advised that they were unable to excavate and repair because of the depth of the pipe. Two excavators were called to provide proposals for repair. Originally it was thought the damaged section could be replaced. However in discussion with the professionals, it was determined this was not feasible and that the entire length of the pipe had to be replaced. The entire length of the pipe is approximately 160 - 180' long, with a depth of approximately 8 - 10'. Two trees in the area were removed due to the proposed excavation. A bid from J.H. Freed Inc., was accepted, and the work is currently in process. Cost for repair will be covered by the Capital Reserve, as \$9,000.00 is set aside each year for storm water drain repairs.




